

# DEPOSIT BONUS

## TERMS AND CONDITIONS

## Deposit Bonus Terms and Conditions

The Program and the conditions associated with it are issued by Prime Capital Markets (PCM) LTD, operating under the trading name *24markets.com*

---

### Regulatory Information

Prime Capital Markets (PCM) LTD is an investment firm regulated by the Financial Services Commission (FSC) of Mauritius, holding Global Business License No. GB23202449 under Code FS-4.1, and operates globally under the trading name *24markets.com* ("the Company").

---

### Promotional Period

This **Deposit Bonus Up to \$10.000** Program ("the Promotion") shall remain valid until **31 December 2025 at 23:59:59 (GMT+3)**, unless terminated earlier at the Company's discretion.

---

### Eligibility

1. The **Deposit Bonus Up to \$10.000** or also marketing it as **50% Deposit Bonus** Promotion is available to new and existing clients of the Company who:
  - Hold a valid real trading account (demo accounts are excluded).
  - Are over the age of 18 (or legal age in their country of residence) and are not considered Minors. The Program is strictly forbidden for Minors.
  - Meet all other onboarding and compliance requirements, including KYC verification.
2. Employees, affiliates, related parties, and intermediaries connected to the Company are **not** eligible to participate. If the registration and/or trading data of a participant corresponds with the registration and/or trading information, including but not limited to IP address, of another participant in the Promotion, PCM LTD reserves the right to regard this matching as a reason for immediate disqualification. Such individuals could be, without limitation:
  - 2.1. family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;

2.2. person or entity, whom any participant in the "50% Deposit Bonus", directly or indirectly through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the "50% Deposit Bonus"; for purposes of this definition, the term "control" (including, with correlative meaning, the terms "controlled by" and "under common control with"), as used with respect to any participant in the "50% Deposit Bonus", shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

3. The Company reserves the right to restrict participation by clients from certain jurisdictions/countries/regions, at its sole discretion.

### Bonus Structure

1. Eligible clients may receive a **Deposit Bonus up to a maximum of USD 10,000 (or currency equivalent)** issued by 24markets.com or Prime Capital Markets (PCM) Ltd. during the Promotional Period.
2. The bonus shall be awarded as follows:
  - **50% on the first deposit**, up to USD 1,000 bonus credit.
  - **20% on all subsequent deposits**, up to a cumulative total of USD 9,000 bonus credit.

### Trading Requirements

1. To convert the bonus into withdrawable funds, clients must trade a minimum of **(bonus amount ÷ 2) standard lots**.
  2. Trading volume requirements apply per deposit, calculated separately and consecutively. Later bonuses cannot be withdrawn until earlier bonus requirements are met.
  3. Profits generated through trading with the bonus are withdrawable at any time, provided the bonus conditions remain valid.
  4. As long as the client submits a withdrawal application, no matter whether the withdrawal is successful or not, the credit bonus will be deducted according to the system logic.
