1. Introduction

These Terms and Conditions ("**Terms**") govern the Refer A Friend ("**Promotion**") offered by Prime Capital Markets (PCM) LTD ("**PCM**" or "the **Company**"), a company registered with Financial Services Commission (FSC) of Mauritius, holding Global Business License No. GB23202449 under Code FS-4.1. By participating in this Promotion, you acknowledge and agree to comply with these Terms.

2. Promotion Period

The Promotion is available from 01 October 2025 until 31 December 2025 ("**Promotion Period**").

3. Eligibility

The Promotion is open to clients who meet the following criteria:

- Must have a STP or ECN trading account with PCM (24markets.com).
- Must be a resident of Eligible Countries/Regions.
- Referrers must not be Introducing Brokers (IBs) or CPAs themselves; however, clients who are directly associated with an IB or CPA may participate as referrers but are not eligible to be referees.

4. Participation Requirements

To participate, referrer must:

- Opt-in to the Promotion by expressing interest via support channel;
- Complete verification during opt-in.

To qualify for the referral reward, the referees must:

- Sign up by contacting support prior to the referee's registration or have the referees register with a unique promo code corresponding to the referral's account number on 24markets.com platform;
- Open a live trading account;
- Complete their identity verification within 24 hours from date of registration;



• Trade a minimum of 4 lots on eligible 24markets products within 30 days from their date of registration.

DEFINITIONS
